

**GALION CITY COUNCIL  
MINUTES OF REGULAR MEETING  
October 24, 2017**

The October 24 2017 meeting of Galion City Council was called to order by President Carl Watt. The Pledge of Allegiance was followed by a moment of silence.

Clerk of Council Julie Bell called roll with the following members present: Mr. Baldinger, Mrs. Bean, Ms. Clark, Mr. Comerford, Dr. Fellner, and Mr. Triplett.

Mrs. Bean made the motion to excuse Mr. Hedges which was seconded by Mr. Triplett. Motion carried.

The roll call for elected officials and officials required by Council Rules and the Ohio Revised Code to be present was called with the following present: Mayor O'Leary, Director of Law Palmer, Treasurer Sparks, and Auditor Treisch.

Department Heads in attendance: Bob Johnston, Chief Jackson, and Matt Echelberry.

President Watt asked for a motion to approve the minutes from October 10, 2017. Mr. Baldinger made the motion to approve the minutes which was seconded by Mr. Triplett Motion carried.

President Watt asked for a motion to add the Galion Community Theatre Liquor License which was made by Ms. Clark and seconded by Mr. Comerford. Matt Echelberry provided an update on the Public Records requests. 77 vs 103 for this time last year. 2016 had a total 112. The police department handles all their own and are not included in those numbers
