

**GALION CITY COUNCIL  
MINUTES OF SPECIAL MEETING (via Zoom)  
October 30, 2020 at 7:00 p.m.**

The October 30, 2020 special meeting of Galion City Council held via Zoom was called to order by President Carl Watt. The Pledge of Allegiance was followed by a moment of silence.

Clerk of Council Julie Bell called roll with the following members present: Mr. Baldinger, Mr. Bodkins, Dr. Fellner, Ms. Erlsten, Mr. Ivy, Mr. Richart, and Mr. Triplett.

The roll call for elected officials and officials required by Council Rules and the Ohio Revised Code to be present was called with the following present: Director of Law Palmer and Safety Service Director Ward.

President Watt asked for a motion to add Ordinance No. 2020-73 to the agenda. Dr. Fellner made the motion seconded by Ms. Erlsten. The roll call on the motion resulted as follows: Mr. Baldinger, yea, Mr. Bodkins, yea, Ms. Erlsten, yea, Dr. Fellner, yea, Mr. Ivy, yea, Mr. Richart, yea, Mr. Triplett, yea. Motion carried 7-0.

President Watt asked for a motion to add Resolution No. 2020-17 to the agenda. Mr. Triplett made the motion seconded by Mr. Ivy. **Legislation**

**Ordinance No. 2020-73 (First Reading)**

An Ordinance amending Ordinance No. 2019-85 (Permanent 2020 Appropriations) by transferring funds and appropriating funds in various funds, and declaring an emergency.

Dr. Fellner made the motion to suspend the rules on Ordinance No. 2020-73 and proceed to the final reading. Ms. Erlsten seconded the motion. **Resolution No. 2020-17 (First Reading)**
